Razvani, my Romanians and the long daily journey to Bucharest

Those who commit crimes now go unpunished, but if 50 politicians were to be imprisoned for serious acts of corruption in Calarasi, they would be afraid, they would not commit robberies, thefts and abuses to the current size. They are allowed to steal!

More than 30 complaints were sent to DNA (National Anticorruption Directorate), only by me, in the last 6 months, for the Organized Crime against the Iacomi Group. The only complaint of which I have certain information, that it arrived at the Lehliu Gara Prosecutor's Office, is the one in which Iulian Iacomi had and still has, the fictitious domicile in a house, where, in fact, he does not live (on Crinului Street). The First Prosecutor of the Lehliu Gara Prosecutor's Office summoned the defendant Iulian Iacomi and they discussed the subject. Later, Iulian Iacomi painted the house in Lehliu Gara but he still does not live there. Otherwise for the thieves there were no other consequences, they went on stoling quietly and unhindered.

Romania is a corrupt state, because it is ruled by people without the necessary training. The tractor driver is a hospital manager, and the mayor has 8 primary classes and has been a mayor for 20 years; he is also an economist.

You can't modernize and functionally maintain a hospital as a tractor driver, just as you can't develop a city when you don't have the cognitive capacity to understand what the city needs, what are its basic needs. The Romanian education system was been almost completely destroyed, in the sense that any person becomes a graduate of the Faculty,

compensating for the lack of cognitive capacity with money. Diplomas in Romania have no value. They all have doctorates, but they are worthless, because behind them, you can't find any competence.

In the last 30 years, all the laws have been modified in such a way that you no longer have the necessary mechanisms to keep the society united, unitary. Thus the segregation of society is inevitable on medium and long term. Around the elections, there is great agitation. There are rivalries, exceptional moves, but the fight is for the power! Money, contracts, hot jobs where you don't have to go to work, but you're greatly paid!

Elections!

In Ivanesti, I found out that 1-2 days ago Ciolacu came to discuss the elections with PSD leaders. Ludovic Orban came to the Rustic Inn (Iacomi Inn) in August, a few weeks ago, after he was first in Calarasi, to discuss the passing of Iulian Iacomi, then president of PSD Calarasi, in the PNL party.

When Orban passed by the Han, the whole town was loud like a hurricane!

But neither Ludovic Orban nor Ciolacu came in Razvani to get out of the car, to talk to people, to see happy children, suffering in people's eyes! They came strictly to see how they could redden the county or how they could turn the county yellow.

To be more exact, they came to find out what money is needed and who wins the election and buys the votes.

BOMB at PSD Calarasi / Mayor of LEHLIU - detained and placed under JUDICIAL control - became PARLIAMENTARY

Before Christmas, the General Anticorruption Directorate investigated him in a bribery case. On December 17, 2015, the magistrates decided, according to judicial sources, to place under judicial control for 60 days the mayor, a close friend of the most influential politician in Bărăgan, Răducu George Filipescu (PNL).

Elections are not free, you are just let to believe they are free.

The games have been made for a long time and the votes have already been bought. Under the guise of legality, a month before the vote, the candidates in Lehliu Gara already have several hundred votes bought.

Everything is mathematics, and the whole system is built and legislated so that from the aspect of democracy, they can keep you enslaved, poor, underdeveloped, so that they can live on your back like parasites.

In the city of Lehliu Gara, an exceptional structure of nepotism was created, an octopus that includes all the structures, from the City Hospital, to ISU and MAI Lehliu Gara.

Remaining unpunished for the deeds committed to the community, with blackmailable and controlled Prosecutors, the Judge is left alone in the face of pressure and does not face, does not resist, that is, the Judge can not do justice, he no longer judges.

Take for example the exceptional stories about Roma who are caught drunk driving, or without a driver's license, in the city of Lehliu Gara or surroundings. At

Lehliu Gara, they receive clemency from Judges and Prosecutors.

The clemency is exceptional, and this is because the thieves from the families from Razvani enter Iulian's office like it was their bathroom whenever they have criminal problems, and Iulian liaises with the Prosecutors and Judges and puts pressure on them.

In Razvani, at the last election, people sold 600 votes to the one who gave more money! In Razvani and Buzoieni, already, Iulian's people buy votes from the poor, tormented, with 50-80 or even 300 lei per vote!

The equation is simple. The turnout must be as low as possible - say 50%. The lower your turnout, the more confident you are. For this, you do everything you can as Mayor, so that the vote goes slowly and badly, with queues and voting spaces as small as possible!

To be uncomfortable, not to want to go to the polls, to hear from the neighbor that you spent hours voting. So all the votes cast are 2650, let's say if 50% of the voters come.

Now it is important to have a few more candidates who will also get a few votes (as it was Micu Filip at Dor Marunt), but not too many! This Micu Filip, Ion Iacomi's man, ran as a diversion and HE was rewarded with a warm place in the City Hall, where he goes when called..

If you need 1700 votes to run for Mayor (ie at a turnout of 50%) and if you have 2 more candidates in which each gets 400 votes, the equation becomes very simple:

- total expressed 1700 votes;
- candidate 1- 400 votes;
- candidate 2-300 votes.

There are 1000 votes left that must be obtained to win detached! Thus, only in Razvani 600 votes are sold!

Here are another 150 votes from teachers, staff from schools, hospitals, kindergartens, etc.

We have 318 fictitious floats brought until today 04.09.2020, to vote with Iulian Iacomi! That is 2018 votes.

This is the election equation in Lehliu Gara City, and the situation is the same in Dor Marunt in proportion!

Iulian Iacomi gave 40,000 euros to a family from Razvani for 200 votes when he came from the Senate, to Oancea to a restaurant, in the forest, near the exis from Lehliu to Lehliu Sat.

That means 900 RON / vote. The chief kept 800-850 RON and 50-100 RON reaches the one who votes.

The shady men become mayors even if you do not vote, because:

1) The whole equation is based on absenteeism, that is, on the fact that you will not go to the polls.

2) Most of those able to work with initiative and strength of work are abroad at work.

The rate of those who go abroad for a better life or a better salary in 2 out of 10. The weak stay at home, parents, the elderly and children in general! These are the vulnerable categories.

3) The average turnout is 50-60%. If they come to the polls 90%, the whole shady men equation falls! They lose the election and people regain what is theirs! The right to life and the right to look at the sun, to raise one's head from the ground. Thus, the money given on the purchased votes is lost money. That's why it's important for you to go to the polls!

Ion and Iulian Iacomi were mayors before the elections, but they are not your mayors!

4) The election equation is based on a system through which the weak and vulnerable are the targets from which votes are obtained. The pressure on them is extraordinary and leads to the transport service home - town hall and return, provided by the candidate's people. Once they get home, after the vote, they receive the money (if they haven't already received it before!).

50-80 RON per vote in Infratirea and Buzoieni. 100 ron in Dalga and Dor Marunt!

900 lei for a vote in Razvani. The money comes with the travel bag and is divided from house to house!

How did the Emperor become the mayor!

Below is a dialogue between our Reporter and a witness in the 2017 elections, which we will call Gheorghe (the complete audio recording is available in full on our website www.experimentullehliu.ro):

"Reporter: -Tables full ... Tables full of votes ... Well, when he ran in December, Iliuță also came to Răzvani.
Reporter: -For what? Did Iliuta come to Razvani? Iliuta !?
Gheorghe: -To buy votes.
Reporter: -So Iliuță went to Răzvani to buy votes.
Gheorghe: -For PNL ...
Reporter: -And the other one buys votes for PSD, Iacomi buys ...
Gheorghe: -In front of the school ... 300 people ... after Iliuță had given them money, children, beer, and everything.
Reporter: -Well, how much did the vote go to them? 300 ron told me that a vote went for Iulian ... 100, with 100, with 100. I mean 100 at ... 100 at ...
Gheorghe: -I don't know that I didn't take it in my life.
Reporter: -Well, what did they do? Iliuță came in front of the school to make cheese ...
Gheorghe: -It's not in front of the school. They gathered somewhere with the clan with ... Iacomi appeared with the deputy mayor, in Răzvani, at the school door, he looked at the gypsies like that ... there was silence ... a gypsy left, he came back, all the gypsies went to the polls and started voting.
Reporter: -Is that why they were waiting in crowd? Were they voting?
Gheorghe: -They were voting after Iliuță had given them the money. And this one came and gave them more. And he didn't overturn the urn as it overturns. I had a man in the room there who told me.
Reporter: -And how did they do it?
Gheorghe: - They took out vote by vote.
That 300 votes they went to and Iliuță had given them money shouldn't be PNL, PNL, PNL? No ... PSD, PSD, PSD ...
Reporter: -Well, wait a minute. But how did they do it? The tickets were in the urn. Well, what did they do?
Gheorghe: - Yes
Reporter: - So, the ones that follow are counted and counted, one by one, one by one, right? Well, what did they do?
Gheorghe: -They didn't overturn it. He took the lid off and they took a vote by vote.
Reporter: -Well, didn't he have to take them all? Not bad...

Gheorghe: -But those 300 that belonged to Iliuță should not only come out PNL?
PSD, PSD, PSD came out ... Iulică came, gave them money ...
Reporter: -Well, the other guy gave them money as well. Didn't this guy give them money?
Gheorghe: -He gave less than Iulică.
Reporter: -I mean, Iulian pulsed more in the vote than the other one.
Gheorghe: -Well, when his brother ran for the office ... Ion (Iacomi-Dor Marunt) with Nițulică ...
Reporter: -Well, you know that in fact he also bought votes, Ion bought votes like hell.
Gheorghe: -Yes.
Reporter: -Some hundred votes. And he bought them.
Gheorghe: - They gave in Dalga 5 million ron per vote. 500 ron per vote.
Reporter: Through the bag... this is a Costel ... By one Costel (n.r. Costel Pantelimon) ...
Gheorghe: -I don't know by whom.
Reporter: -500 ron? Did they give so much?
Gheorghe: - Nițulică also gave money... he also gave.
Reporter: -I mean, Nitulica also gave votes ...
Gheorghe: -Well, yes ... So, the mayor wins with money. That's how they taught the world. He says ,, What do you give me to vote for Laurențiu ...? ,, I give you something! I will ask him (money) and I will give it to you. Yes?
Reporter ”-So these people are bitter and miserable, because they are bitter and tormented people ... they are also stupid, but they are also bitter.
You see, poverty overwhelms you. Poverty, helplessness ...
Gheorghe: -Poor and stupid. Take my money and go there and vote!
Reporter: -So they actually buy votes everywhere hard.
Gheorghe: -Now they are going with money. And I know who they are.
Reporter: -These of Iacomi or these of Banescu?
Gheorghe: -No, his no.
Reporter: -These of Iacomi, right?
Gheorghe: - Mihai Orzea, you know him.
Reporter: - This Mihai Orzea is from ...
Gheorghe: - It's from Dor Mărunt.
Reporter: - Yes, I know about him, I heard about him he is from...
Gheorghe: - And he has a house in Lehliu.
Reporter: - Mihai Orzea buys votes and walks around with people and takes their bulletin first?
Gheorghe: -No. He makes them take a picture.
Reporter: -Picture of what? The vote?
Gheorghe: -At the vote bulletin.
Reporter: -And how much does he give them? 100 ron?
Gheorghe: - one hundred, two ... not 1 million ..
Gheorghe: -50 ron, 50, 30

Reporter: -How can he give 50, 30 per vote?

Gheorghe: -Well, if I tell you? That's the price they sell themselves.

Reporter: - 30 and 50 ron are sold here to these people?

Well, it means they are poor! They are extremely poor! Tortured ...

Gheorghe: -I say that they are more fools than poor people. Well, what do I do with 50 ron? With 300 ron if you give me ... what do I do with them?

Reporter: -So the gypsies said that 350 votes only went to Răzvani. Chash, Pesin! Money down on the table!

He came with the money bag and that, he came with the money bag and that!

Gheorghe: -Both of them did ...

Reporter: - And he took the money from both of them!

Gheorghe: -Yes ... And this was the result.

Reporter: -And Iulian won the election ...

Gheorghe: -Yes, because he gave more money.

Reporter: -Well, I didn't understand how did they processed the votes. What do you mean he took them and counted them? I do not understand. I mean, what has he got to do with how he counted them? What could they do?

Gheorghe: -That's the urn, right? Good...

Reporter: -Was there an urn in Răzvani !? Were there more?

George: -No. Two. Two sections. I go and talk to the gypsies.

Reporter: -Yes, get out of here ... get out there and this guy is defeated ...

Gheorghe: - All the gypsies came 200, 150, 250, 300 They came and sat in line to vote.

Reporter: - Yes, to vote! All gathered around!

Gheorghe: Normally and by law, they should have voted PNL... as it was known that Iliuță gave money? And while they were queuing to enter the section, the mayor (n.r. Iulian Iacomi) and the vice (n.r. Doru Ivan) came.

Reporter: -The vice was also came?

Gheorghe: -Who now he took out for good, he wanted to beat him ...

Reporter: -What vice, what's his name?

Gheorghe: -Doru Ivan from Răzvani.

Reporter: -Doru Ivan from Razvani?

Gheorghe: -His father was a party instructor, a man of great value.

Reporter: -Is it all from Răzvani? This is a gypsy ...

Gheorghe: -He's not.

Reporter: -And with the vice Iulian bought the votes. They talked, they gave the money and ...

Gheorghe: -He came, he gave them money, they talked to them: come in, vote and I'll give you the money. And now, the moment you opened the urn and took the lid ... and you started taking the vote bulletin, it was, of course, as it was known ...

Reporter: -To turn over the urn, so that it is not clear who voted who. That is, not to know how they entered, to mix ...

Gheorghe: -They didn't overthrow the urn, because there was a man in the room who had doubts, meaning he was a PNL member.

Reporter: -And why did he have doubts? Not to steal? To not...

Gheorghe: -He had doubts that those who voted did not vote for Iliuță, that is, PNL ... they voted for PSD.

Reporter: -And they wanted to see exactly who voted to know ...

Gheorghe: -Yes.

Gheorghe: -And when he started taking the bulletins...

Reporter: -Everyone was with PSD, of Iulian (n.r. Iulian Iacomi is now running for PNL)

Reporter: -So they saw exactly who came in to see who voted and depending on how much money he gave. I mean, that one cheated on you or he didn't cheat on you.

Reporter: -Iliuță was cheated on and this one (n.r. Iulian Iacomi) became mayor.

Gheorghe: -He worked him really good! And the other one came out mayor. And he will do so now.

Gheorghe: -They will do the same now. Don't you see? They haven't done anything for 12 years and today they started repairing pits. Have you seen?

Reporter: -Yes, yes. I saw, yes ...

Gheorghe: -.....

Reporter: - Yes, well, his brother-in-law repaired them. The last time his brother-in-law repaired them. He got asphalt wastes from Ichim Marian, that's the asphalt wastes from the highway, he mixed it with liquid pitch, that liquid from Dedeman, not that liquid that must be really heated. With liquid tar, that's the type with water in it. So, mixed, it's not water, it's a solvent. So. And he would pour two of those shovels (asphalt wastes) and put a little bit of that liquid. He was dealing with the burner, a compactor that he bought from Emag for 1000 RON and he gave about 60,000 euros to his brother-in-law. The one that is ... there's a locality down here ... if it has two companies ... what's its name? He is from his family ... "The recording continues in the following articles.

People are left alone, they are abandoned by the authorities transformed into annexes of some thieves. MAI structures are infiltrated by parasites, people who have nothing to do with the uniform!

Same goes with the local police, which is actually the mayor's police, an element of oppression.

In Dor Marunt, for example, although Mayor Ion Iacomi is always driving drunk the DMP car of Dor Marunt City Hall, no one ever stopped him for control, not even once! When he arrives at the City Hall, Ion Iacomi serves with Nea Nicu (Garage), at his store, a glass of wine, and I saw with my own eyes not once,

then he gets behind the wheel! Nea Nicu takes the bike! Nobody stops him, and if someone ever would, Iolanda would come with the team and she would solve the problem at the hospital (see the article on this subject)!

Ion Iacomi bought votes, Iulian Iacomi bought votes, Iliuta Vasile bought votes, and the elections ended up being a mess, a circus, in which we are all dumb pieces on a Lego board!

The USR candidate at Lehliu Gara has the mission given by Bucharest to help the PSD candidate, sorry, PNL, meaning Emperor Julian! The USR candidate is running as a joke, for a hot post!

Translation of sms messages received by our Reporter from the USR candidate:

Very briefly: July 15, PNL Calarasi and USR Calarasi agreed to have a united, common candidate in many localities in Calarasi, to face the local PSD party. In Lehliu, I was the only common candidate, PNL-USR. After a few days, Iacomi came to the PNL Calarasi headquarters with the offer to transfer to them. The local leaders didn't even want to hear, but a phone call came from Bucharest: you have to accept him! and they did. Obviously, I categorically refused any collaboration with the one I was supposed to face as PSD mayor for three terms (and president of the PDS county party).

That's how we got in this situation. Now I have to do my campaign with a lot of diplomacy, in order not to blow up the PNL-USR electoral alliance at the level of the County Council and of many city halls from Calarasi (Budesti, Nana, Oltenita, Chirnogi, Argovei Valley, etc.), where PNL and USR have common candidates and common lists.

The USR candidate is sincere, in good faith, but in the quarter of a century when he was absent from Lehliu, things have been arranged, the books are done.

The elections are no longer free, "free will disappears", the corruption wins! But the corrupt politicians of Razvani are 100 times more human than Buraga and Pacione combined! More sincere, more hardworking!

Lehliu Gara City Hall, a few years ago, accepted a series of compromises through which the water from Bunge / Prio factory was transported by cistern under the bridge from A2, and from here it reached directly into the forest, in the stream where also the city sewage treatment plant also discharged.

Iulian Iacomi and Lehliu Gara City Hall accepted, authorized and implemented together with Bunge / Prio factory the construction of a plastic pipe to connect the Bunge / Prio factory to the city's sewerage system at the end of the street on DN3, near the LPG station.

With the approval of the mayor Iulian Iacomi, Prio / Bunge pulled a pipe and connected it to the sewerage system of the City the Biodiesel Refinery, with a plastic pipe that is actually for water, not for petrochemical residues.



The pipe was connected to a sewer system designed for parameters that have nothing to do with the Prio / Bunge connection! Lehliu's city system is a gravitational one!

Often the discharged water contains acids, bases, organic / inorganic chemical compounds, and is pumped at a pressure of 6-8 bar in the urban sewage system...

The canal is next to the entrance panel of the locality

Acids and petrochemical compounds from refinery water, due to high pressure and flow, for which the urban sewerage system was not designed, have destroyed the City's SEWERAGE SYSTEM in the last 12 years in certain areas!

Exceptionally corrosive chemicals destroyed the sewer system, which had to be rebuilt from scratch. Moreover, infiltrations from damaged sewer pipes reached the groundwater and turned the groundwater into a chemical soup.

If we consider here the large number of excavated lakes (see articles on lakes on the website www.experimentullehliu.ro), by members of the criminal group Iacomi in the last 10 years, in the groundwater, the image of the disaster is complete.

The sewerage system in Lehliu Gara

We further present you the dialogue between our reporter and a witness that we will call Marin (the complete audio recording is available in full on our website www.experimentullehliu.ro):

"Reporter: -You see, I don't need many names, but I want the truth. I, for one, can't know everything. I'm a man. Yes, you see, a man with a man, with a man, ... I have to find out and see what happens and why this mayor had to change half the sewer system in the city, but I'll tell you a secret that I don't know if you know: These acids that they put in and the bases destroyed the asbestos cement, consumed it, made it full of holes. All that sludge goes into the underground water. You can't use the underground water anymore, you can't drink it in Răzvani, in Lehliu Gară ... you can't drink it anymore. It's poison. Everything went to hell. And now they're changing the sewerage system, that's all! It's war there and everything is destroyed!

Marin: -He also has a relative there ..

Reporter: -Iacomi? Who does he have there? Seriously?

Marin: -a nephew ...

Marin: -At the water pumping station there, does he have a nephew?

Reporter: -A nephew? Isn't that Meserie's?

Marin -I think ...

Reporter: - Meserie's guy (n.r. deputy mayor Dor Marunt)

Marin - In Calarasi. The director of Ecoaqua is ... Iulian's brother-in-law.

Reporter: -Yes?

Marin: -Yes. It only has two million euros ... the hole ...

Reporter: -Iulian Iacomi's brother-in-law ... really!?

Seriously? He also has a guy there? The brother-in-law is ... Who is the brother-in-law? Don't you know his name?

Marin: -I don't know ...

Reporter: -He is there at Ecoaqua in Calarasi. Well, that's why they do everything they want here, boy! Well, this sewer system ... so, these came from Bunge. What did they do ... These people came from Bunge, when they came, after they made that factory, they didn't build a treatment plant. They took and carried the tank. Gigi showed me. And they would bring it to the sewage treatment plant and throw it in there.

Marin: -They are not doing that anymore.

Reporter: -No. They made a pipe. They constructed a pipe that goes straight to the entrance to Lehliu Gară, on DN (National Road). There they put the pipe directly into the sewer and the sewer goes directly.

The problem is that the flow is very powerful, at 8-10 bar, and when the sludge comes with such high flow, you will notice that the 120 (inch) pipe it fills the sewer. It doesn't work properly, the flow goes the other way, it mixes with the city's sewerage, it goes the other way. You understand me. And that's why the city's sewer was completely destroyed. Do you understand? Because the acid dissolves the concrete. It dissolves it! It dissolves it! It destroys it, it makes it dust! And everything was drilled, cracked.

Marin: -...

Reporter: -Now, do you know how they did it, for example? When they first came here, they didn't have a sewage treatment plant.

Marin: -No

Reporter: -No. When they did it now, the sludge was still untreated ... do you understand me? Because it costs to clean and clean, it costs ... They have pools, they built something there, yes ..., and these guys drain the sludge at night, but it's a huge amount ...

This PRIO factory consumes three times as much as the city of Lehliu Gară consumes drinking water ... It consumes enormously four times.

Marin: -But where do they get the water from?

Reporter: -They have five wells in the groundwater. Five fountains. ”

Iulian Iacomi started the project to restore the sewerage due to the flow pumped by the refinery, a flow that caused the wastewater to rise towards the city, their water practically reaching the city's sewerage in areas where it was not allowed to reach.

The Bunge / Prio refinery did not clean and does not clean the water properly (it costs money, a lot of money, a lot of money to clean according to the quality standard), and the mayor accepted out of love for Lehliu citizens and did not even take money from the owners of Bunge / Prio to authorize such a thing, for more than a decade!

The Lehliu Gara Wastewater Treatment Plant is not designed to take up wastewater with petrochemical residues!

Water drainage is performed systematically through the following networks: domestic sewerage, meteorological sewerage and industrial sewerage. The water from the sanitary installations will be collected in four watertight, watertight basins. The meteoric waters will be collected from the paved surfaces and the roof of the buildings and directed through an internal sewerage network in a retention basin with a capacity of 2240 m³. The technological wastewater resulting from the production sectors will be collected by an internal sewerage network and directed to the treatment plant. The resulting water will be discharged into a concrete retention basin with a capacity of 1000 m³. From here, the waters will be initially drained, and in the future, by connecting to the city sewer, they will be sent to the treatment plant of Lehliu Gara. In order to ensure an increased degree of environmental protection, the treated water on the site will comply with the provisions of NTPA 001/2005

Excerpt from the Report on the impact on the environment-2009 Sc Aldim ASA SRL.

Due to the pressure of 8-10 bar at the sewer mouth on DN3, the water with petrochemical residues rose due to the flow to the city, where in a few years, the sewer pipes, installed during socialism, were partially dissolved by the chemical soup. Water with acids and corrosion inhibitors entered the soil, groundwater and in this way something had to be done with the sewer!

**Solution: Replace the sewer system!
But even this new sewer system is not designed to pick up chemical residues.**

Pavels are stolen early in the day!

The boys from Bertoni, the company that executes the works in Lehliu Gara, the company of Iulica's godfather, Vasile Grigore, instead of finalizing the contract given to them and their relatives (the one with the city sewerage), with the mayor's consent, loaded a full car with pavement in front of the park.

Pavement that was good and can be moved to another location. But they, with the truck, carried 15 tons of pavement to their home, in Dor Marunt!

The pavement was removed in the area between BCR and Nemes store.

The pavement reached Mitica from Dor Marunt on Nicolae Balcescu Street, a good friend of Iulian Iacomi! Instead of staying in Lehliu Gara and being mounted on Serei Street, for example, or in Razvani, where people are left to their fate by Lehliu Gara City Hall, the pavement in downtown Lehliu is loaded and stolen in the bucket, right in front of our faces! Although he knows that all but absolute we are all watching them, their Mayor, Iulian Iacomi steals in broad daylight, from the city center!

Nea Mitica: - I don't know who. You should talk to someone from the company that works there through Lehliu. I do not know...

Reporter: -At Bertoni? Well, who did you talk to, Mr. Mitica?

Nea Mitica: - What does it matter who I talked to or not? I needed it at home.

Reporter: -Well, it's very important! Mr. Mitica, I understand that you need ... we all need. Who should I speak to? With the boss from Bertoni or with Iulian Iacomi?

Nea Mitica: - I don't know who to talk to, because if I tell you I may give you the wrong information to talk to ... Leave them alone that because of this campaign, I brought some debris at the gate and they started coming to film it, I don't know what ... What ... damn it, sir? This is a joke ...

Reporter: -Well, you see ...

Nea Mitica: - Am I interested in how much you steal? I don't care if you steal, but leave me alone!

Reporter: -No, listen to me a little. Yes, don't be upset. Wait a minute ...

Nea Mitica: - Nobody gives you the right to film me at my gate! It's private property there.

Reporter: -Private? No, it's a public domain, Mr. Mitica, it's a public domain. You put the tiles on the public domain.

Nea Mitica: - Well, public domain in pictures, yes, that also captures my house.

Reporter: -Well, the house is caught there in the picture if she is built there ...

Nea Mitica: - What do you mean by "if it is built there"? Mind your own business, damn it!

Reporter: -Yes, I understand ...

Reporter: -You were hired by the Ministry of Internal Affairs as far as I know, on ISU, right?

Nea Mitica: - And what is your problem with the fact that I worked there?

Reporter: -I was expecting something ... how can I tell you, morality ...

Nea Mitica: - I did not swear, I spoke quite politely, but please, leave me alone!

Reporter: -I leave you, yes.

Nea Mitica: - Well then?

Reporter: -I just wanted to know who to talk to, I also want to put some tiles in the yard ... But have you thought about the people on the streets of Lehliu Gară, who at the moment do not have a single stone on the street? Wouldn't they want to put those tiles on the street or in their yards?

Nea Mitica: - I have other more important things to do now than to listen to you.

Reporter: -Thank you, Mr. Mitica and I wish you a nice day! ”

During the clearing of the streets of Lehliu Gara, Mrs. Roxana Stoica (former Iacomi), the niece of the mayor Iulian, harshly criticizes the naughty citizens of the city, who dare to comment on something: „Lehliu is a beautiful city, it is true that now it is a bit messy due to the sewerage and

Mrs. Roxana Stoica is the Chief of the R.U.N.O.S. Human resources, normative, organization, salary (R.U.N.O.S.) service of Lehliu Gara City Hospital, manager Danga Vasile.

She holds the staff of the hospital with an iron fist, where she was hired at the end of high school, after failing the Final Exam only once. The second time, this minor detail was resolved.

Meanwhile, the Lehliu citizens swim in the mud and there are many streets in the city that look like a field! The young people are struggling to draw electricity, gas, water, sewage! 
Thus, according to the previous experience, they started the large utility transporter (vola), and one of the two (without having a certificate for heavy equipment or driving license) mounted the bucket instead of the pallet fork.

As Hristu Costel and Alin (his nephew and employee on the tractor) went to the field with the equipment, the two workers used the machine (vola) to change the lighting fixtures. Thus, one of the two boys climbed into the machine's cup, and the second handled the machine. As the two used to drink alcohol, from Hristu Costel in the bar, early in the morning, they used to argue on various topics! On the day in question, the

one in the cup yells at the driver to keep the machine in one place to change the lighting fixtures. The driver got angry and wanted to make a joke! He wanted to shake the one in the cup "a little".

Due to the age of the machine and the lack of experience and qualification, the driver touched the bucket lever too much and the bucket made a complete fold. Hristu Costel goes to Ion Iacomi on the day of this tragic accident for help, knowing that Ion and Iulian Iacomi are good friends with Dumitru Nicolae (Chief Inspector of ITM Calarasi). He asks for their full support in order to "solve the case" as discreetly and quickly as possible. Thus, following the discussions, it appears that ITM Calarasi can solve the partial case, but it will also be a work accident, because it was registered in Calarasi as a "suspicious crime"!

Consequently, Dumitru Nicolae, sends on the evening of the death a colleague (reliable ITM Inspector) who solves the administrative part before the control of ITM Calarasi, (which occurred after the notification of the Prosecutor's Office / Prosecutor's Office of Calarasi). The help arrived at Dalga Gara, teaches Christ Costel what and how to do and together they produce documents!

First of all, a set of pre-dated employment contracts is falsely drawn up!

The occupational health and safety training of the "dead" is falsely drawn up. Dumitru solves Revisal through "guides"! It is solved with the revision registration of fictitious employment contracts (there are traces in the Revisal system, traces that are still in the system). Fake training sheets are drawn up for the two people, related to working at height.

A series of training sheets is prepared for the driver, for the use of such equipment. Some fictitious pay slips are written. Hristu Costel is given the necessary instructions regarding why and how he should declare the next day to the Prosecutor and ITM Calarasi. Dumitru Nicolae's colleague, leave!

The investigation begins! Hristu declares that the dead man is employed and begins the ITM inspection in parallel. The state of the work accident is ascertained, with the fulfillment of all the labor protection rules and the fact that the two climbed to change light bulbs by their own will!

The Calarasi Prosecutor's Office through the "friendly" Prosecutor makes a minimal investigation and does not find the "real" facts as they happened! ITM Calarasi, following the control arranged by Dumitru Nicolae, Ion Iacomi and Iulian Iacomi, gives a small

“modest” fine to Mr. Hristu Costel and a set of measures that he must implement. Hristu Costel buries the dead on his own expense! The dead man also has a brother who works at "Geli", a mixed store, a few hundred meters away.

For this help, Hristu Costel promised, among other things, 12,000 euros to Iulian Iacomi and in addition 10 trucks of corn.

Hristu Costel pays "in the bank account" of Iulian Iacomi "a loan" in the amount of 12,000 Euros. And the 10 trucks, at harvest, as they agreed. The corn trucks were carried by Dobre Florin, directly from the field of Hristu.

Separately, Hristu "borrowed" Julian. The amount of money appears in the wealth declaration of Iulian Iacomi dated 05.12.2016, in the form of a loan agreement with no. 4529.

In this fictitious loan contract, the money was given directly from the account of Hristu Costel and the case with the death was relatively buried, both at the prosecutor's office and at ITM Calarasi.


